## ADVOCACY

### AADOOCR Capitol Hill Day

On October 20, six members of AADOOCR's Government Affairs Committee traveled to Washington, D.C. for a series of meetings with federal legislators on Capitol Hill. The meetings provided AADOOCR's chief advocates the opportunity to meet with lawmakers who have jurisdiction over funding levels for NIH and NIDCR and/or play a key role in advancing priority legislation such as the Advanced Research Projects Agency for Health (ARPA-H) Act, the Ensuring Lasting Smiles Act, and the Oral Health Literacy & Awareness Act.

The annual AADOOCR/FNIDCR Advocacy Day will be held in Washington, D.C. in March 2023. The exact date and additional details will be announced soon.

### Outcome of 2022 Midterm Election Still Uncertain

Democrats outperformed pre-election expectations and historical odds in the midterm elections on Tuesday. At time of printing, the Republicans seem poised to regain control of the U.S. House, but by a considerably slimmer margin than expected. Control of the U.S. Senate hinges on the outcome of races in Nevada, Georgia, and Arizona, which remain too close to call. In Georgia, it appears neither Senate candidate will surpass the 50% threshold needed to avoid a December runoff election, which could again determine control of the upper chamber, just as it did two years ago. A full recap of the midterm election results, including its potential




consequences on dental, oral, and craniofacial research and federal oral health programs, will be published on the [AADOCR Government Affairs Blog](#) in the coming days.

## CMS to Expand Medicare Coverage of Dental Services

On November 1, the Centers for Medicare & Medicaid Services (CMS) finalized the 2023 [Medicare Physician Fee Schedule \(MPFS\) rule](#), which codifies current policies requiring Medicare Parts A and B to pay for dental services when the services are integral to the medical condition of beneficiaries. AADOCR submitted a [letter](#) during the open comment period in support of the proposal. The rule also allows for greater Medicare coverage of dental examinations and treatments, such as to eliminate infection preceding an organ transplant, certain cardiac procedures and treatment for head and neck cancers. Finally, CMS is establishing an annual process during which the agency will consider other circumstances when payment for dental services may be permitted.

## Applications for Summer 2023 NIDCR Dental Public Health Research Fellowship Program Open Now

The National Institute of Dental and Craniofacial Research (NIDCR) is pleased to announce that applications for its Dental Public Health Research Fellowship (DPHRF) program are now open. The three-year fellowship includes a 12-month full-time residency in Dental Public Health (DPH) followed by a 24-month full-time postdoctoral fellowship with a strong focus on oral health research.

A stipend may be available to support Dental Public Health Research fellows during the three-year program. This training opportunity requires a full-time commitment, and those selected cannot be enrolled in other training programs.

Individuals successfully completing the 12-month DPH residency component will receive a certificate of completion and are qualified educationally to apply for examination by the American Board of Dental Public Health (ABDPH) for specialty certification.

Equal consideration is given to all applicants without regard to race, religion, color, national origin, sex, sexual orientation, political affiliation, or age.

## Celebrating Native American Heritage Month

Throughout the month of November, we celebrate Native American Heritage Month. It is an opportunity for us to reflect upon and celebrate the countless contributions of American Indian and Alaska Native peoples to our culture and society and recognize their central role in U.S. history. As a people, their rich cultural heritage, triumphs, and community impact is undeniable but add to that – their enrichment of the field of dental, oral, and craniofacial health across the ages. The Native American community has undoubtedly provided an essential service with the design of the earliest syringes to inject medicine and irrigate wounds and the use of goldthread as mouthwash to clean the oral cavity.

This community has also led the way in pain relief with the discovery and use of several natural pain relievers containing chemicals found in modern day over the counter medications. The Native American population faces many impediments to oral care and currently suffer from the worst oral health outcomes in comparison to any racial or ethnic group within the United States. In many Indigenous communities, dental disease can be found in 90% of young children, ages 3-5. Further research is needed to increase access and address oral health knowledge within these communities. With that backdrop, the Committee on Diversity and Inclusion (CDI) has proposed organizations that

champion underrepresented groups for member donations. If of interest, the CDI would like to offer the following for your financial or in-kind support:

- **National Indian Health Board - Tribal Oral Health Initiative** – bringing together stakeholders including Tribal leaders, Tribal health directors, Area Indian Health Boards, Tribal Epidemiology Centers, and public health leaders to explore solutions and develop recommendations to address oral health disparities and lack of access to oral health treatment and prevention services in Indian Country.
- **Indigenous Student Affairs Network** – dedicated to creating a home base and means of connection for student affairs educators that work towards improving the retention of Indigenous college students.
- **Native American Connections** – committed to improving the lives of individuals and families through Native American culturally appropriate health, affordable housing, and community development services.
- **Society of American Indian Dentists** – purposed to promote dental health in the American Indian Community, encourage American Indian Youth to pursue a career in the profession of dentistry, provide role-model leadership and support the unique concerns of American Indian Dentists.

The [NIH Loan Repayment Program \(LRP\)](#) is now open for applications. All qualified health professionals with doctoral degrees, apply now to the 2023 application cycle. Applications are accepted through online application portal until **November 17 at 8:00 p.m. ET**.

The LRP offers loan repayment awards of up to \$50,000 per year for up to 2 years. Awardees commit to engage in NIMHD and NIH-mission relevant minority health and health disparities research in non-federal settings for at least two years.

Since its inception, the NIMHD LRP has repaid the student loans of over 2,200 doctorate-level health professionals. Awardees have worked in a variety of disciplines, including medicine, epidemiology,

psychology, social science, medicine, and health policy. LRP recipients have conducted research on areas such as cardiovascular disease, cancer, diabetes, HIV/AIDS, infant mortality, asthma, obesity, and kidney disease. Their investigations have examined biological, lifestyle, environmental, social, economic, institutional, cultural, and family influences on health disparities.

This year, **Giving Tuesday is November 29, 2022.**

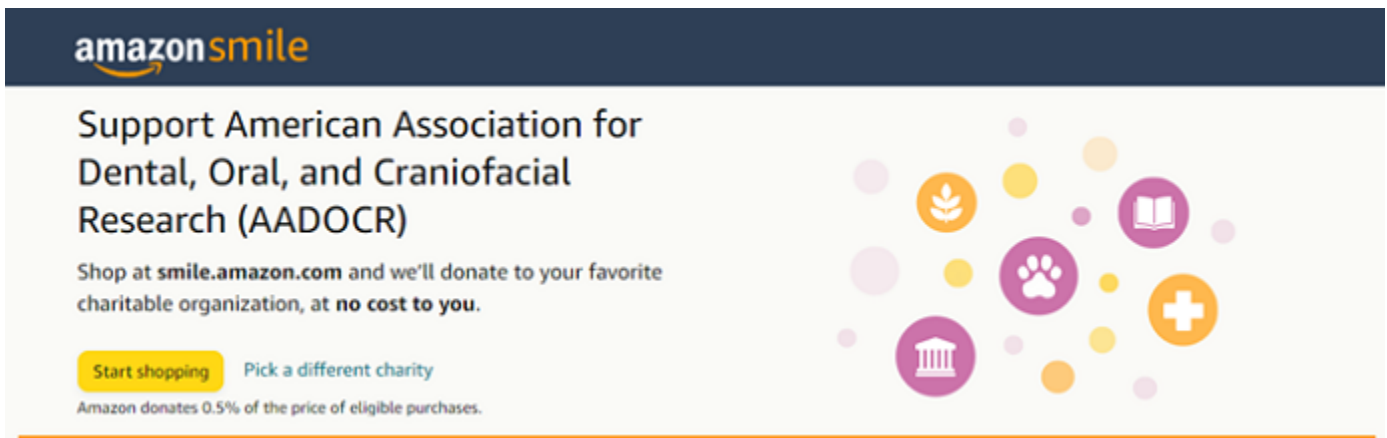
