



AADR Oral Health Effects of Tobacco Products: Science and Regulatory Policy Meeting

The AADR Oral Health Effects of Tobacco Products: Science and Regulatory Policy meeting took place on September 14, 2018 in Bethesda, Md., USA. This meeting brought together experts to discuss research on the suite of tobacco products regulated by the Food and Drug Administration, including smokeless tobacco and e-cigarettes, and their impacts on the oral microbiome, oral epithelium, dental caries and carcinogenesis, among other topics. Experts and attendees also identified research needs to help guide regulatory policy.

On February 28, 2018, deans, researchers, students, patients and other oral research stakeholders from across the country convened in Washington, D.C. for the 2018 AADR/FNIDCR Advocacy Day on Capitol Hill.

MESSAGE FROM THE PRESIDENT



It has been both an honor and a pleasure to serve as the president of the American Association for Dental Research. I have been privileged to work alongside other dedicated members of the Board of Directors to support the Association's mission of advancing oral and craniofacial science, increasing knowledge for the improvement of oral and overall health, supporting and representing the oral health research community and facilitating the communication and application of research findings.

The AADR along with the International Association for Dental Research (IADR) announced that the *JDR* holds its highest 2-Year Impact Factor at 5.380. This is the first time that the *JDR* has achieved an Impact Factor above 5 and marks a 13% increase from its 2016 Impact Factor [2017 Journal Citation Reports® (Clarivate Analytics, 2018)]. With over 19,000 citations, the *JDR* was proudly recognized for the most citations in the "Dentistry, Oral Surgery & Medicine" category.

The 47th Annual Meeting of the AADR was held in conjunction with the 42nd Annual Meeting of the Canadian Association for Dental Research (CADR) at the Greater Fort Lauderdale/Broward County Convention Center. The 2,727 attendees from 39 countries were welcomed to attend 1,316 poster presentations, 317 oral presentations, 18 Lunch & Learning topics, 24 symposia, five hands-on workshops, four satellite symposia, three Distinguished Lecture Series plenary sessions and 41 exhibition booths. In addition, early pre-meeting sessions included a Faculty Development Workshop: Mentoring Mentors and Mentees as well as a joint AADR and American Association for the Advancement of Science (AAAS) Science Communication Fundamentals workshop.

Two additional AADR meetings were held in the Fall of 2018. The AADR Oral Health Effects of Tobacco Products: Science and Regulatory Policy conference, supported in part by an R13 grant from the Food and Drug Administration, allowed for discussion among leading tobacco products experts on current knowledge and existing research gaps regarding the oral health effects of tobacco related products. The 9th AADR Fall Focused Symposium: Advances in Precision Oral Health Research, supported in part by The Task Force on Design and Analysis in Oral Health Research and an R13 grant from the National Institutes of Health, addressed the current state of precision oral health research and its clinical application as well as the future of precision oral health and the research gaps that need to be filled to realize the full potential of precision oral care.

Additional highlights and successes from 2018, including our advocacy efforts on Capitol Hill to ensure sustained funding for the National Institute for Dental and Craniofacial Research (NIDCR), are illustrated in this year's Annual Report. These accomplishments were made possible through the support of dedicated members of the AADR.

AADR's current and future success relies on you, our AADR members. Having an engaged membership who is committed to conducting the best science possible and willing to serve the association will help the organization flourish, further execute AADR's mission and secure the future of this important organization, strengthening our field of science.

I encourage all individual AADR members and Corporate and Institutional members to remain engaged in the Association as we continue to fulfill our mission and further develop our vision for the future including enhanced membership and professional development experiences over the next year and beyond.

Under the leadership of President Maria Emanuel Ryan, an outstanding Board of Directors and a dedicated staff, the American Association for Dental Research has successfully completed another year of key accomplishments toward furthering our mission and in delivering outstanding membership services. AADR members were able to enjoy the implementation of new programs this year, and you can expect to see new initiatives in 2019.

This year, AADR was again actively involved in national legislative affairs and advocacy. On Tuesday, February 27, 2018, researchers, deans, students, patient advocates and other oral health research stakeholders joined together in Washington, D.C. for the 2018 AADR and Friends of National Institute of Dental and Craniofacial Research (FNIDCR) Advocacy Day on Capitol Hill to raise the profile of dental, oral and craniofacial research among federal policymakers. Participants visited with approximately 45 offices, where they encouraged policymakers to provide additional funding to the federal research enterprise, including National Institutes of Health and National Institute of Dental and Craniofacial Research, in Fiscal Year 2018 and in 2019 legislation.

Developing the next generation continues to be an AADR goal that is supported through the Association as well as AADR's donor campaign. The AADR National Student Research Group (NSRG), a student-run organization that supports student's research and dental education, announced a new research competition titled 411 Rapid Research that will make its debut at the 97th General Session of the International Association for Dental Research (IADR), which will be held in conjunction with the 48th Annual Meeting of the American Association for Dental Research and the 43rd Annual Meeting of the Canadian Association for Dental Research (CADR), from June 19-22, 2019 in Vancouver, BC, Canada. The award, judged by the NSRG board, will consist of two categories, basic science and clinical/public health. Please see the Philanthropic Update on page 6 for additional updates and to learn how you may contribute toward the future of dental, oral and craniofacial research.

Looking ahead, 2019 marks the Centennial of the *Journal of Dental Research*. To celebrate, the *JDR* will feature a yearlong commemorative article series and a podcast series that highlights topics that have transformed dental, oral and craniofacial research over the past 100 years, as well as a reception following the Opening Ceremonies of the 2019 IADR/AADR/CADR General Session.

In 2020, IADR will proudly celebrate its Centennial and highlight the accomplishments of the greatest contributors to craniofacial, oral and dental research worldwide. Planning started in 2016 and will continue to ensure an exceptional celebration in Washington, D.C.

In closing, I am grateful for the achievements AADR and its members gained this year. I express my continued gratitude to President Maria Emanuel Ryan and the entire Board of Directors who believe in AADR and work tirelessly to support the Association's mission.

Journal of Dental Research



The Journal of Dental Research (JDR) now holds its highest 2-Year Impact Factor in the "Dentistry, Oral Surgery & Medicine" category at **5.380**. This is the first time the Journal's Impact

Factor has reached above 5 and marks a **13% increase** from its 2016 Impact Factor. [2017 Journal Citation Reports® (Clarivate Analytics, 2018)].

- ▲ The JDR continues to rank #1 of 91 journals in the "Dentistry, Oral Surgery & Medicine" category in Eigenfactor with a score of **0.02095**.
- ▲ The JDR ranks #2 in Impact Factor, Article Influence, with a score of 1.546, and 5-year Impact Factor which remained above 5 for the third year at 5.715.
- ▲ With over **19,000 citations**, the *JDR* also boasts the most citations in the "Dentistry, Oral Surgery & Medicine" category.

JDR Special Issue: Head and Neck Cancer

University of California, San Diego, USA served as the guest editors.





Advances in Dental Research

Two issues were published in Volume 29 of Advances in Dental Research, an e-Supplement to the JDR.

- ▲ "International Conference on Novel Anticaries and Remineralizing Agents 3 (ICNARA)" published in February 2018 included proceedings and papers from the International Conference on Novel AntiCaries and Remineralizing Agents 3 (ICNARA 3) which sought to summarize the current status of caries management and highlight exciting new therapeutic possibilities and future research needs.
- ▲ "Guidelines for Fluoride Intake—Are They Appropriate?" was published in March 2018. This issue included the proceedings of a symposium at the 95th General Session of IADR on March 22-25, 2017 in San Francisco, USA and is comprised of reviews that critically examine the current guidelines for fluoride intake.

Membership Marketing Redesign

In 2018, AADR underwent a membership marketing redesign. Carefully designed graphics reinforce the AADR mission, strengths and values. Along with the new look for AADR membership ads and collateral, AADR developed a set of icons to better communicate member benefits and to fit with current marketing best practices for print and email communications.



ANNUAL REPORT

ADVOCACY & GOVERNMENT AFFAIRS UPDATE

Over the course of 2018, there were several developments that affected federal research and programs. The **Bipartisan Budget Act of 2018**, signed into law in February 2018, represented the largest single increase to domestic spending since the American Recovery and Reinvestment Act of 2009. As a result, the subsequent fiscal year (FY) 2018 spending package provided many significant increases across the U.S. Department of Health and Human Services (HHS), including a **\$3 billion increase to the National Institutes of Health.** AADR was proud to work alongside our colleagues on both efforts to ensure that research agencies received the increases needed to fulfill their missions.

2018 AADR and FNIDCR Advocacy Day on Capitol Hill

On Tuesday, February 27, 2018, researchers, deans, students, patient advocates and other oral health research stakeholders joined together in Washington, D.C. for the 2018 AADR and Friends of National Institute of Dental and Craniofacial Research (FNIDCR) Advocacy Day on Capitol Hill to raise the profile of dental, oral and craniofacial research among federal policymakers.

During the event, participants heard from NIDCR Director Martha Somerman and Congressman Mike Simpson (R-ID) and visited with approximately 45 offices, where they encouraged policymakers to provide additional funding to the federal research enterprise, including NIH and NIDCR, in fiscal year (FY) 2018 and 2019 legislation.

Friends of NIDCR and the Patient Advocacy Council

The Friends of NIDCR continues to build on its work to champion NIDCR and those who depend on its critical research. Among FNIDCR's 2018 activities were hosting the co-branded AADR and FNIDCR Advocacy Day on Capitol Hill and submitting organizational sign-on letters containing funding requests for NIDCR to federal policymakers.

Part of FNIDCR, the Patient Advocacy Council also had an exciting year. The Council welcomed **four new members** — CCD Smiles, Ear Community, Soft Bones and the Lymphangiomatosis & Gorham's Disease Alliance — and enhanced its programming to add value for Council members. New in 2018, the Council hosted an in-person meeting with NIDCR leadership in February so that Council members could learn about the Institute's portfolio and initiatives.

AADR and FNIDCR Submit Outside Witness Testimony to Congress

AADR Chief Executive Officer Christopher Fox submitted outside witness testimony to both the House and Senate Labor, Health and Human Services, Education and Related Agencies Appropriations Subcommittees detailing the FY 2019 funding requests of AADR and the Friends of NIDCR and outlining the importance of investments in dental, oral and craniofacial research, NIH and NIDCR to the nation's health and well-being.

AADR's Efforts to Raise Oral Health Research Visibility

AADR remained an active member in several public health and scientific research coalitions to expand the reach of its messages, amplify its voice and visibility and demonstrate oral health research's role in the broader community. AADR worked alongside its partners on initiatives, including:

- ▲ NDD United and Research!America's #RaiseTheCaps campaign
- ▲ 2018 Rally for Medical Research
- Oral-health focused congressional briefing
- ▲ Coalition for Health Funding's Public Health Fair
- ▲ NIH's *All of Us* Research Program.

AADR also regularly engaged with members of Congress and the administration to ensure policymakers remained aware of the continued contributions of NIH, NIDCR, CDC and other federal research agencies and programs and to request steady, sustained funding increases so these agencies can fulfill their promise to the American people.

Periodontitis is one of the most common inflammatory human diseases with a strong genetic component. Due to the limited sample size of available periodontitis cohorts and the underlying trait heterogeneity, genome-wide association studies of chronic periodontitis have largely been unsuccessful in identifying common susceptibility factors. A combination of quantitative trait loci mapping in mice with association studies in humans has the potential to discover novel risk loci.

Results from microbiome studies on oral cancer have been inconsistent, probably because they focused on compositional analysis, which does not account for functional redundancy among oral bacteria. This case-control study confirms that a dysbiotic, inflammatory bacteriome is associated with oral squamous cellcarcinoma and that microbial communities with different species composition can be functionally similar: an indirect evidence of functional redundancy among oral bacteria taxa. This study generates hypotheses that need to be confirmed in direct functional analysis with a metatranscriptomic approach.

Human tRNA-Derived Small RNAs Modulate Host-Oral Microbial Interactions

Coevolution of the human host and its associated microbiota has led to sophisticated interactions to maintain a delicate homeostasis but emerging evidence suggests that in addition to small molecules, peptides and proteins, small regulatory noncoding RNAs (sRNAs) might play an important role in crossdomain interactions. This study reveals the presence of diverse host transfer RNA-derived small RNAs (tsRNAs) among human salivary sRNAs and provides the first line of evidence for the modulatory role of host-derived tsRNAs in the microbial-host interaction.

Tooth agenesis is a developmental anomaly defined as the absence of ≥1 permanent teeth. Authors present association results from a large genome-wide association study of tooth agenesis and tested the association of previously identified risk variants, for timing of tooth eruption and orofacial clefts, with tooth agenesis. Five associate with selective tooth agenesis, including a variant conferring risk of orofacial clefts. These results contribute to a deeper understanding of the genetic architecture of tooth development and disease and knowing the etiology and clinical features of tooth agenesis is important for planning oral rehabilitation that often involves an interdisciplinary approach.

The pattern and timing of primary tooth emergence in an American Indian (AI) population during the first 36 months of life were determined and compared with other U.S. ethnic groups. Primary teeth erupted earlier in Al children than in the Hispanic and Non-Hispanic White children studied. No sex differences in tooth emergence or in the number of teeth present at a specified age were found in either of these groups. The findings, that the primary teeth of Al children emerge sooner than teeth in other populations, may explain the high rates of caries in AI children and suggests the need for earlier prevention protocols.




An overview of 23 systematic reviews was carried out to determine the association between periodontal disease and adverse pregnancy outcomes. Consistent evidence from these reviews indicate that pregnant women with periodontal disease are at increased risk of developing preeclampsia and delivering a preterm and/or low birth weight baby. These results affirm that every pregnant woman should be screened for periodontal disease and those with periodontal disease should receive periodontal care.







In 2019, the IADR/AADR/CADR General Session & Exhibition will be held in Vancouver, BC, Canada from June 19-22. 2019 marks the Centennial of the *Journal of Dental Research (JDR)*.

To celebrate, the JDR will feature a yearlong commemorative article series, podcast series and a collection of video interviews that highlight topics that have transformed dental, oral and craniofacial research over the past 100 years. At the 2019 IADR/AADR/CADR General Session & Exhibition, the JDR Centennial will be celebrated during the Opening Ceremonies and the accompanying reception with a historical display highlighting JDR's significance over the past 100 years.

NEW! AADR/Procter & Gamble Underrepresented Faculty Research Fellowship

The new AADR/Procter & Gamble Underrepresented Faculty Research Fellowship supports researchers from underrepresented racial and ethnic groups at the early stages of their scientific careers and to increase representation of these underrepresented groups at the faculty level in science and academia. Recipients will receive \$10,000 that must be put towards their post-doctoral research, establishment of their laboratories, the completion of a research project or preparing research for publication or grant submission. This award is supported by an unrestricted grant from the Procter & Gamble Company.

NEW! 411 Rapid Research Competition to Launch at 2019 IADR/AADR/CADR General Session

The new 411 Rapid Research competition will make its debut at the 2019 IADR/AADR/CADR General Session. Student competitors will have 4 minutes and 1 slide to explain their research. The student will then be asked 1 question, hence the name 411. The award will consist of 2 categories, basic science and clinical/public health. Seven competitors will be selected to compete in each category. The AADR National Student Research Group will serve as judges for this competition.


